**Market Report**

**Wednesday, 11<sup>th</sup> July 2018**

DSE recorded a total turnover of TZS 23.36 mln from 41,167 shares traded in 32 deals.

On Government Bonds counter, a 7-years bond with a coupon rate of 10.08% and a face value of TZS 523 mln was traded at 90.6253% and 96.2601% in 2 deals and a 15-years bond with a coupon rate of 13.50% and a face value of TZS 2.2 bln was traded at 105.8940%, 96.8477%, 97.2479% and 95.8696% in 4 deals.

CRDB counter had 1,750 shares traded at weighted average price of TZS 160 per share in 5 deals. DSE counter had 1,700 shares traded at weighted average price of TZS 1,600 per share in 5 deals. NICO counter had 36,300 shares traded at weighted average price of TZS 220 per share in 8 deals. TBL counter had 685 shares traded at weighted average price of TZS 16,500 per share in 9 deals. TPCC counter had 482 shares traded at weighted average price of TZS 1,800 per share in 4 deals. VODA counter had 250 shares traded at weighted average price of TZS 800 per share in 1 deal.
