On Government Bonds Board, 7-year bond with a coupon rate of 10.08% and a face value of TZS 0.12 bln was traded at 84.5083% in 1 deal(s) while 10-year bond with a coupon rate of 11.44% and a face value of TZS 3.00 bln was traded at 92.0481% in 1 deal(s) while 15-year bond with a coupon rate of 13.50% and a face value of TZS 3.01 bln was traded at 96.4659%, 97.1726%, 99.1183% in 4 deal(s) while 20-year bond with a coupon rate of 15.49% and a face value of TZS 0.04 bln was traded at 95.5304% in 2 deal(s). On Corporate Bonds Board, a 3-year bond with a coupon rate of 13.00% and a face value of TZS 2.00 mln was traded at 100.2298% in 1 deal(s)
