Chairperson's Statement



"The quality of power continues to remain a problem affecting plant output negatively".

Despite the world economic turmoil towards the end of 2008, Tanga Cement had a record year. Revenue increased year on year by 29%, while earnings per share rose by 28%. Domestic sales volumes have grown by 9% year on year. Improvements in operational efficiencies helped to contain non-fuel costs. However, the steep rise in world coal prices at the beginning of the year resulted in higher energy cost.

The quality of power continues to remain a problem affecting plant output negatively. The decrease in international fuel prices towards the end of the year have not yet fully transpired in Tanzania and high fuel prices continue to impact transportation cost. The automation of the plant was completed by the end of year as planned. This improvement will enhance reliability and operational safety in future.

Dividends:

During the year the Company paid interim dividend of Tzs 7.9 billion which amounts to Tzs 120 per share. Due to the ongoing expansion project for the new grinding unit, the Board does not propose a final dividend for the year.

Prospects:

The construction of the new cement mill is progressing well. It is planned to be commissioned in the third quarter of 2009. The world economic slump is also currently being felt in Tanzania. Importation of cement has already increased during 2009. The Company is watching the world cement price development carefully.

Considering the uncertainty of the current economic conditions the Company expects a modest improvement in 2009.

Appreciation:

I will be retiring from the Board at the May Annual General Meeting. I would like to thank the Board, management and staff of Tanga Cement for all the support they have given me during my time as Chairperson of the Board. During this time the company has listed on the DSE, installed a coal mill, modernised large sections of the plant and is about to complete a new cement mill. Needless to say the profitability and share price of Tanga Cement has also grown dramatically over this period. I wish Tanga Cement and all its stakeholders everything of the best in the current uncertain economic times.

Waraka wa Mwenyekiti



"Tatizo la umeme limeendelea kuathiri vibaya uzalishaji kiwandani."

Pamoja na mtikisiko wa hali ya uchumi duniani mwishoni mwa mwaka 2008, Tanga Cement imekuwa na rekodi nzuri kwa mwaka huo. Mapato yameongezeka kwa 29% wakati mapato kwa hisa yamepanda kwa 28%.

Kiasi cha mauzo ya ndani kimekua kwa 9% ukilinganisha na mwaka 2007. Uboreshaji wa ufanisi wa endeshaji umesaidia sana kudhibiti gharama zisizokuwa za mafuta. Hata hivyo ongezeko kubwa la bei ya makaa ya mawe duniani mwanzo wa mwaka wa taarifa hii limesababisha gharama kubwa za nishati.

Tatizo la umeme limeendelea kuathiri vibaya uzalishaji kiwandani.

Kupungua kwa bei za mafuta duniani mwishoni mwa mwaka bado hakujaonekana kwa ukamilifu nchini Tanzania na bei kubwa za mafuta zinaendelea kuathiri gharama za usafirishaji.

Uwekaji mfumo wa kisasa wa kujijendesha wenyewe kwenye mtambo umekamilika mwishoni mwa mwaka kama ilivyopangwa. Uboreshaji huo utaimarisha kuaminika na usalama wa uendeshaji siku zijazo.

Gawio:

Katika mwaka wa taarifa hii, Kampuni imelipa gawio la kati la Tzs 7.9 bilioni ambazo ni sawa na Tzs 120 kwa hisa. Kutokana na mradi wa upanuzi unaoendelea wa kitengo cha usagishaji, Bodi haipendekezi gawio la mwisho kwa mwaka husika.

Matarajio:

Ujenzi wa mtambo mpya wa saruji unaendelea vizuri. Unatarajiwa kuanza uzalishaji katika robo ya tatu ya mwaka 2009. Kudorora kwa uchumi duniani nako kumeanza kuigusa Tanzania. Uagizaji wa saruji kutoka nje tayari umeongezeka katika mwaka 2009. Kampuni inafuatilia kwa makini mwenendo wa bei ya saruji duniani. Kutokana na kutokuwa na uhakika wa hali ya uchumi ya sasa duniani, Kampuni inatarajia maendeleo ya wastani katika mwaka 2009.

Shukrani:

Natarajia kustaafu kutoka katika Bodi wakati wa mkutano mkuu wa mwaka mwezi Mei. Napenda kuishukuru Bodi, menejimenti na wafanyakazi wa Kampuni ya Saruji Tanga kwa msaada wao walionipa wakati nikiwa Mwenyeiti wa Bodi. Katika kipindi hicho, Kampuni imejiandikisha katika soko la Hisa la Dar es Salaam (DSE), kufunga mtambo unaotumia makaa ya mawe; kufunga mitambo ya kisasa katika sehemu kubwa za kiwanda na inakaribia kukamilisha kufunga mtambo mwingine wa Saruji. Aidha napenda kusema kuwa faida na bei ya hisa ya Kampuni ya Saruji Tanga, vimeongezeka sana katika kipindi cha taarifa hii. Napenda niitakie heri na mafanikio Kampuni ya Tanga Cement na wadau wake katika kipindi hiki cha hali mbaya na isiyotabirika ya uchumi.

Managing Director's Report

"The new mill will increase our cement production capacity from the current 750,000 tons to 1,250,000 tons."

Our 2008 figures once again show the impact of operational improvements. We achieved a new production and sales record of 709,000 tons of cement. This volume does represent a market share of 41% and a 9.1% growth over 2007 figures. Profit after tax increased by 28% despite the increased cost of fuel and the negative impact of the worsening power supply situation from TANESCO during the year.

The new Cement Mill project has commenced and is scheduled to be completed in the second half of 2009. The new mill will increase our cement production capacity from the current 750,000 tons to 1,250,000 tons.

Due to the sudden change in the Government's policy on import duties and the oversupply of cement on the global market, combined with freight rates collapsing, we saw at the end of the year a substantial increase of cement imports into Tanzania. We are working with the government to bring back the suspended duties as well as installing a specific tariff as an anti-dumping measure to protect the cement industry in Tanzania.

Achievements in 2008:

- 709,000 tons of cement produced and sold.
- 28% growth in our net profit after tax.
- Started construction of the new cement mill, clinker silo and packing plant, as a turn-key contract with the Chinese contractor CBMI.
- We concluded successfully the modernization of the plant control system and the electrical installations in November last year; this will enhance further the operational safety of our plant and production processes.
- Additional emergency generators were installed, resulting in a back-up power supply of more than 8MW (75% of our maximum demand) to deal with the increasing deteriorating power supply from TANESCO.
- Due to the success of our USALAMA Program on Occupational Health & Safety, we had only one minor Lost-Time-Injury accident during the year. Tanga Cement is certainly a benchmark in Tanzania for the exemplary efforts made to prevent accidents. Our safety program is not only restricted to employees but includes our contractors' employees as well.
- As part of our environmental awareness we substantially reduced the dust emissions from the plant to well below the local limits. Additionally, we continued with our program of quarry rehabilitation in Tanga (limestone quarry) and Holili (pozzolana quarry). At Holili we handed over to the village a fully rehabilitated quarry planted with sisal and trees. Government representatives expressed their satisfaction on the work done and will use it as an example within Tanzania for quarry rehabilitation.

Challenges in 2008:

Unreliable power supply continues to be the biggest challenge for Tanga Cement. This has resulted in not just production losses but also a safety risk to our employees. Unfortunately this problem is worsening without signs of improvement. This threatens industrial development of the country making local production increasingly uncompetitive against imports from more industrialized countries in the Middle East and Asia.

The critical situation on logistics for receiving of spare parts, machinery and consumables and long delays in the ports and the almost non-operational railway infrastructure is adding an immense cost to our production and distribution of cement. Consequently the cement prices in Tanzania are on the higher side affecting the normal growth of consumption due to the fact that people with lower income may not be able to buy cement for their construction projects.

Future Prospects:

The global financial crisis is having its impact on the Tanzanian economy and the construction sector. GDP growth projections have been lowered and a lot will depend on how effective the monetary policy of the Bank of Tanzania is in managing inflation, exchange rates and interest rates; all factors directly affecting the construction growth.

Cement demand for the country is projected to grow to 1.9 million tons in 2009 (an increase of 6.7% on 2008). However, the increasing imports of cement will pose a threat to the local cement industry. Consequently we are expecting only a moderate growth of our results in 2009 compared to 2008.

"Mtambo mpya utaongeza uwezo wa uzalishaji wa saruji kutoka tani za sasa 750,000 hadi tani 1,250,000."

Hesabu zetu za mwaka 2008 zinaonyesha tena matokeo ya uboreshaji wa uendeshaji. Tumepata rekodi mpya ya uzalishaji na mauzo ya tani 709,000 za saruji. Kiasi hicho cha uzalishaji kinawakilisha hisa ya soko ya 41% na ongezeko la 9.1% ikilinganishwa na hesabu za mwaka 2007. Faida baada ya kulipa kodi imeongezeka kwa 28% ingawa kulikuwa na ongezeko la bei ya mafuta na athari iliyotokana na hali mbaya ya umeme kutoka TANESCO katika mwaka wa taarifa hii.

Mradi wa mtambo mpya wa saruji (cement mill) umeanza na unatarajiwa kukamilika katika nusu ya pili ya mwaka 2009. Mtambo mpya utaongeza uwezo wa uzalishaji wa saruji kutoka tani za sasa 750,000 hadi tani 1,250,000.

Kutokana na mabadiliko ya ghafla katika sera ya serikali kuhusu ushuru wa bidhaa zinazoagizwa nje ya nchi na kufurika kwa soko la saruji duniani, pamoja na kupungua kwa viwango vya gharama za usafirishaji, mwisho wa mwaka tumeshuhudia ongezeko kubwa la saruji kuingizwa nchini Tanzania. Tunashauriana na serikali ili kurudisha ushuru uliofutwa pamoja na kuweka viwango mahususi vya ushuru wa forodha kama hatua ya kuzuia uingizaji bidhaa holela nchini na kulinda viwanda vya Saruji nchini Tanzania.

Mafanikio ya mwaka 2008:

- Tani 709,000 za saruji zimezalishwa na kuuzwa.
- Ongezeko la 28% la faida halisi baada ya kodi na ushuru.
- Tumeanza ujenzi wa mtambo mpya wa saruji (cement mill), silo la kuhifadha na mtambo wa kufungashia kulingana na mkataba wa kukabidhiwa kwa matumizi na mkandarasi wa Kichina, CBMI.
- Tumekamilisha kwa mafanikio makubwa kufunga vifaa vya kisasa vya mfumo wa udhibiti wa mitambo na vifaa vya umeme mwezi Novemba mwaka jana, hii itaimarisha zaidi usalama wa uendeshaji wa mtambo wetu na taratibu za uzalishaji.
- Majenereta ya dharura ya ziada yalifungwa na kufanya jumla ya umeme wa kuongezea wa zaidi ya 8MW (75% ya kiwango cha juu cha mahitaji yetu) ili kushughulikia upungufu wa umeme wa TANESCO.
- Kutokana na mafanikio ya Programu ya USALAMA katika Afya na Usalama Kazini, tumekuwa na ajali moja tu ndogo ya kupoteza muda wa uzalishaji katika mwaka wa taarifa hii. Kama kampuni. Hatuna shaka kwamba sisi ni mfano wa kuigwa nchini Tanzania kwa juhudi za kupigiwa mfano za kuzuia ajali. Programu yetu ya usalama haiwahusu wafanyakazi wetu peke yao bali pia wafanyakazi wa makandarasi wetu.
- Kuhusu kuzingatia athari ya mazingira, tumepunguza kwa kiasi kikubwa utoaji vumbi kutoka katika mtambo hadi kufikia chini ya viwango vya nchini. Aidha, tumeeendelea na programu yetu ya ukarabati wa machimbo ya mawe (magange)Tanga na machimbo ya Holili (machimbo ya pozzolana) ambako tumekabidhi kijiji machimbo ya mawe yaliyokarabatiwa kwa ukamilifu yaliyopandwa mkongwe na miti. Wawakilishi wa serikali wameonyesha kuridhishwa kwao na kazi iliyofanyika na wataitumia nchini Tanzania kama mfano wa ukarabati wa machimbo ya mawe.

Changamoto katika mwaka 2008:

Umeme usioaminika bado inabaki kuwa changamoto kubwa kwa kiwanda chetu. Hali hiyo si tu kama imesababisha upungufu wa uzalishaji na kuleta hasara bali pia hatari kwa wafanyakazi wetu. Bahati mbaya tatizo hili linazidi bila kuonyesha dalili ya kupungua, na kuwa tishio kubwa kwa maendeleo ya viwanda nchini na kufanya uzalishaji bidhaa ushindwe kukabili ushindani wa bidhaa zinazoingizwa nchini kutoka nchi zenye viwanda zaidi vya Mashiriki ya Kati na Asia.

Hali mbaya ya usafirishaji kwa upokeaji wa vipuri, mitambo/ mashine na bidhaa za matumizi, wenye ucheleweshaji mkubwa bandarini na miundombinu ya reli isiyofanyakazi au isiyokuwapo kabisa inaongeza gharama kubwa katika uzalishaji na usambazaji wa saruji. Matokeo yake, bei za saruji ziko juu nchini Tanzania na hivyo kuathiri kukua kwa kawaida kwa matumizi yake kutokana na ukweli kwamba watu wenye kipato cha chini watahindwa kununua saruji kwa ajili ya miradi yao ya ujenzi.

Matarajio ya Baadaye:

Mtikisiko wa hali ya fedha duniani unaonyesha athari kubwa kwa uchumi wa Tanzania na hasa sekta yake ya ujenzi. Matarajio ya ukuaji wa GDP yamekuwa ya chini na itategemea sana kufaa kwa sera ya fedha ya Benki kuu ya Tanzania (BoT) katika kudhibiti mfumko wa bei, viwango vya kubadilisha fedha za kigeni na viwango vya riba, vipengele vyote hivyo vimeathiri moja kwa moja ukuaji wa ujenzi.

Mahitaji ya saruji nchini yanatarajiwa kukua na kufikia tani 1.9 milioni mwaka 2009 (ongezeko la 6.7% kulinganisha na mwaka 2008), hata hivyo, ongezeko la uingizaji saruji kutoka nje, litasababisha tishio la wazi kwa sekta ya saruji nchini. Matokeo yake, tunatarajia kupata ongezeko dogo tu la uzalishaji mwaka huu (2009) ikilinganishwa na mwaka 2008.
