

DAR ES SALAAM STOCK EXCHANGE Market Report Tuesday 21st January 2014

In today's trading session, DSE recorded a total turnover of TZS 566.84 mln from 160,301 shares traded in 67 deals in comparison to the previous session which recorded a turnover of TZS 28.07 mln from 24,847 shares traded in 35 deals. Today, foreign investors generated a turnover of 432.82 mln from the purchase of 43,000 CRDB shares, 10,300 NMB shares, 199 DCB shares and 48,500 TBL shares while on sale foreign investor generate a turnover of 14.41 mln from 5,416 NMB shares.

CRDB counter had 16,242 shares traded at weighted average price of TZS 295 per share in 23 deals. NMB counter had 19,816 shares traded at weighted average price of TZS 2,660 per share in 12 deals. TWIGA counter had 3,816 shares traded at weighted average price of TZS 2,660 per share in 6 deals. DCB counter had 6,585 shares traded at weighted average price of TZS 490 per share in 7 deals. TBL counter had 5,343 shares traded at weighted average price of TZS 8,100 per share in 12 deals. SIMBA counter had 100 shares traded at weighted average price of TZS 2,340 per share in 1 deal. TOL counter had 200 shares traded at weighted average price of TZS 310 per share in 1 deal. SWISSPORT counter had 5,700 shares traded at weighted average price of TZS 8,600 per share in 1 deal. DCB counter had 8,500 shares on bid at TZS 490 per share and 20,000 shares on offer at TZS 500 per share. NMB counter had 93,600 shares on bid at TZS 2,660 per share and 36,400 shares on offer at TZS 2,800 and TZS 2,760 per share. PAL counter had 34,300 shares on offer at TZS 470 and TZS 495 per share. TWIGA counter had 8,500 shares on offer at prices ranging from TZS 2,640 to TZS 2,800 per share. TBL counter had 71,500 shares on bid at TZS 8,000 per share and 24,600 shares on offer at TZS 8,100 and TZS 8,500 per share. SIMBA counter had 23,900 shares on bid at prices ranging from TZS 2,320 to TZS 2,360 per share. TCC counter had 11,900 shares on bid at TZS 8,600 per share.
