DSE recorded a total turnover of TZS 123.30 mln from 536,997 shares traded in 37 deals; and TZS 4.53 Billion from bond traded in 6 deals.

In the Normal Board, CRDB counter had 534,029 shares traded at weighted average price of TZS 220 per share in 13 deal(s). DCB counter had 20 shares traded at weighted average price of TZS 250 per share in 1 deal(s). DSE counter had 770 shares traded at weighted average price of TZS 900 per share in 5 deal(s). JATU counter had 490 shares traded at weighted average price of TZS 2,400 per share in 3 deal(s). TCCL counter had 140 shares traded at weighted average price of TZS 470 per share in 4 deal(s). TPCC counter had 1,548 shares traded at weighted average price of TZS 2,500 per share in 11 deal(s).

On the Government Bonds Board, a 10-year bond with a coupon rate of 11.44% and a face value of TZS 0.10 bln was traded at 92.2335% in 1 deal(s) while a 15-year bond with a coupon rate of 13.50% and a face value of TZS 0.04 bln was traded at 109.7255% in 1 deal(s). The market also traded a 20-year bond with a coupon rate of 15.49% and a face value of TZS 4.16 bln at prices of 87.0378%, 100.4092% and 105.9431% in 4 deal(s).

On the Corporate Bonds Board, a 3-year bond with a coupon rate of 10.00% and a face value of TZS 1.30 mln was traded at 90.5526% in 1 deal(s).
