Thursday 13th March 2014

In today's trading session, DSE recorded a total turnover of TZS 1,222.18 mln from 213,706 shares traded in 36 deals in comparison to the previous session which recorded a turnover of TZS 143.23 mln from 196,881 shares traded in 33 deals. Today, foreign investors generated a turnover of 1,030.04 mln from the purchase of 121,150 TBL shares and 100 NMB shares.

CRDB counter had 30,605 shares traded at weighted average price of TZS 315 per share in 17 deals. NMB counter had 800 shares traded at weighted average price of TZS 2,660 per share in 4 deals. DCB counter had 5,000 shares traded at weighted average price of TZS 490 per share in 2 deals. TBL counter had 5,000 shares traded at weighted average price of TZS 8,000 per share in 4 deals. SWISSPORT counter had 50,751 shares traded at weighted average price of TZS 2,700 per share in 5 deals. SIMBA counter had 400 shares traded at weighted average price of TZS 2,480 per share in 1 deal.

On pre-arranged crossings board, TBL counter had 121,250 shares traded at TZS 8,500 per share in 2 deals

When the session was closed CRDB counter had 2,700 shares on bid at TZS 310 and TZS 300 per share and 876,900 shares on offer at prices ranging from TZS 320 to TZS 355 per share. DCB counter 45,500 shares on bid at TZS 475 and 564,600 shares on offer at TZS 490 per share. NMB counter had 9,900 shares on bid at TZS 2,660 per share and 40,000 shares on offer at prices ranging from TZS 2,700 to TZS 2,800 per share. SWISSPORT counter had 29,500 shares on offer at TZS 2,700 per share. TWIGA counter had 62,800 shares on offer at prices ranging from TZS 2,500 to TZS 2,700 per share. TBL counter had 8,400 shares on offer at TZS 8,100 and TZS 8,000 ex dividend per share. SIMBA counter had 12,200 shares on bid at TZS 2,460 and TZS 2,480 per share. TCC counter had 200 shares on bid at TZS 8,600 per share. MAENDELEO counter had 9,000 shares on offer at TZS 600 per share. TOL counter had 36,600 shares on bid at TZS 305 and TZS 310 per share.
