Market Report

Tuesday 18th June 2013

Today, DSE recorded a total turnover of TZS 110.30 mln from 353,679 shares traded in 48 deals in comparison to the previous session which recorded a turnover of TZS 10,862.97 mln from 3,199,103 shares traded in 65 deals. Meanwhile on the Government Bond Market Board, a five year 9.18% bond with a face value of 2.5 bln was traded at TZS 92.0862% in 1 deal.

CRDB counter had 337,200 shares traded at weighted average price of TZS 220 per share in 31 deals. TOL counter had 400 shares traded at weighted average price of TZS 260 per share in 1 deal. SIMBA counter had 2,900 shares traded at weighted average price of TZS 2,400 per share in 5 deals. TWIGA counter had 699 shares traded at weighted average price of TZS 2,640 per share in 3 deals. TBL counter had 4,580 shares traded at weighted average price of TZS 3,180 per share in 3 deals. NMB counter had 7,900 shares traded at weighted average price of TZS 1,600 per share in 5 deals.

When the session was closed on CRDB counter there were 748,000 shares on bid at prices ranging from TZS 210 to TZS 220 ex dividend per share and 80,000 shares on offer at TZS 235 per share. On DCB counter there were 200 shares on bid at TZS 380 per share and 24,100 shares on offer at TZS 440 and TZS 400 per share. On NMB counter, there were 105,300 shares on bid at TZS 1,600 per share. On PAL counter, there were 34,000 shares on bid at TZS 475 per share. On SWISSPORT counter there were 6,000 shares on bid at TZS 1980 and TZS 2000 per share. On TBL counter there were 22,900 shares on bid at TZS 3,180 and TZS 3,160 per share. On TCC counter there were 10,000 shares on bid at TZS 6,000 per share. On SIMBA counter there were 1,100 shares on bid at TZS 2,400 per share. On TOL counter there were 80,500 shares on bid at TZS 260 per share. On TWIGA counter there were 5,000 shares on bid at TZS 2,640 per share.

Meanwhile, on AON Board there were 15,500 TCC shares on bid at TZS 6,500 per share and 50,001 SWISSPORT shares on bid at TZS 2,000 per share.
