Wednesday 28th May 2014

In today's trading session, DSE recorded a total turnover of TZS 515.32 mln from 575,919 shares traded in 84 deals in comparison to the previous session which recorded a turnover of TZS 32.41 mln from 46,166 shares traded in 43 deals.

CRDB counter had 485,300 shares traded at weighted average price of TZS 310 ex dividend per share in 43 deals. NMB counter had 61,222 shares traded at weighted average price of TZS 3,220 cum dividend per share in 22 deals. TBL counter had 2,197 shares traded at weighted average price of TZS 8,240 per share in 4 deals. SWISSPORT counter had 1,100 shares traded at weighted average price of TZS 2,600 per share in 1 deal. DCB counter had 2,100 shares traded at weighted average price of TZS 490 per share in 4 deals. TCC counter had 100 shares traded at weighted average price of TZS 10,100 per share in 1 deal. TWIGA counter had 11,200 shares traded at weighted average price of TZS 2,440 per share in 6 deals. SIMBA counter had 700 shares traded at weighted average price of TZS 2,400 per share in 2 deals. Today foreign investors generated a total turnover of TZS 5.70 mln from the purchase of 18,400 CRDB shares. Furthermore, foreign investors generated a total turnover of TZS 166.62 mln from the sale of 50,800 NMB shares. On Pre-Arranged Crossing Board, NMB counter had 50,800 shares traded at TZS 3,280 per share in 1 deal whereas TBL counter had 12,000 shares traded at TZS 9,220 per share in 1 deal.

When the session was closed CRDB counter had 10,300 shares on bid at TZS 305 ex dividend per share and 365,300 shares on offer at prices ranging from TZS 310 to TZS 325 ex dividend per share. DCB counter had 27,400 shares on bid at TZS 480 ex dividend per share and 123,700 shares on offer at TZS 490 ex dividend per share. NMB counter had 45,000 shares on bid at prices ranging from TZS 3,100 to TZS 3,200 cum dividend per share. TWIGA counter had 54,500 shares on offer at TZS 2,460 and TZS 2,700 per share. TBL counter had 140,300 shares on bid at prices ranging from TZS 8,240 to TZS 8,180 per share. TCC counter had 1,400 shares on bid at TZS 10,100 per share. SIMBA counter had 23,100 shares on bid at TZS 2,360 per share and 4,800 shares on offer at TZS 2,400 ex dividend per share. TOL counter had 100 shares on bid at TZS 450 per share.
