iTrust Finance Limited wishes to inform the general public that, pursuant to Sections 17.7 of the Trust Deed of the iTrust EAC Large Cap Exchange Traded Fund, the Fund has implemented its Q1 2026 portfolio rebalancing in accordance with the approved investment and asset allocation framework. The rebalancing comprises adjustments to the weights of selected constituent securities and the inclusion of an additional eligible security, with the objective of maintaining alignment with the Fund's mandate and ensuring continued compliance with the Trust Deed and applicable regulatory requirements.

### SUMMARY OF THE REBALANCING

The rebalancing comprises the inclusion of Stanbic Holdings Plc Kenya (SBIC) at 3.50%; a listed stock on the Nairobi Securities Exchange (NSE), together with adjustments to the weights of selected existing constituents across Kenya, Tanzania and Uganda, with the objective of enhancing portfolio liquidity, investability and strengthening diversification. The summary changes are highlighted in the table below:
