Tanzania Launches Its First Exchange Traded Fund (ETF): Vertex International Securities ETF (VIS-ETF) Listed on the DSE

The Capital Markets and Securities Authority (CMSA), the Dar es Salaam Stock Exchange (DSE) and Vertex International Securities Limited are pleased to announce the successful listing of Tanzania's first Exchange Traded Fund (ETF) dubbed Vertex International Securities Exchange Traded Fund (VIS-ETF).
