#### **Financial Review**

I am pleased to announce the business results for the fourth quarter ended 31 December 2024.

Revenue increased by 22% in 4Q24 compared to the same period last year. The increase in revenue was driven by volume, strong performance in the core beer portfolio, revenue management initiatives and category mix.

Our performance was led by a solid performance of core beer portfolio and spirit business delivering a high double-digit topline growth for the Company in 4Q24.

Operating profit increased by 168%, driven by topline performance, productivity and supply chain efficiencies and a one-off impact in other expenses in the previous year financials.

As a result, the operating margin for the quarter increased to 20.9% compared to 9.5% over the similar period last year.

Finance costs deteriorated in the quarter due to a negative impact from foreign currency exchange rate fluctuations.

Profit before tax for the quarter increased by 158% driven by topline performance and cost efficiencies.

During the quarter a total of TShs 35,439 million was invested in capital expenditure compared to TShs 14,158 million in the previous quarter. In addition, cash generated was utilized in operational activities, including a corporate tax payment of TShs 21,500 million.

Our performance would not have been possible without the hard work and dedication of our people, we thank them for their passion and commitment in delivering the results. I would also like to thank our customers and consumers of our brands for their continued support and trust in our brands.

Other prominent brands associated with the TBL Group are Konyagi Gin, Valuer Brandy, Zanzi Creamy Liqueur and Dodoma and Imagi wines.
